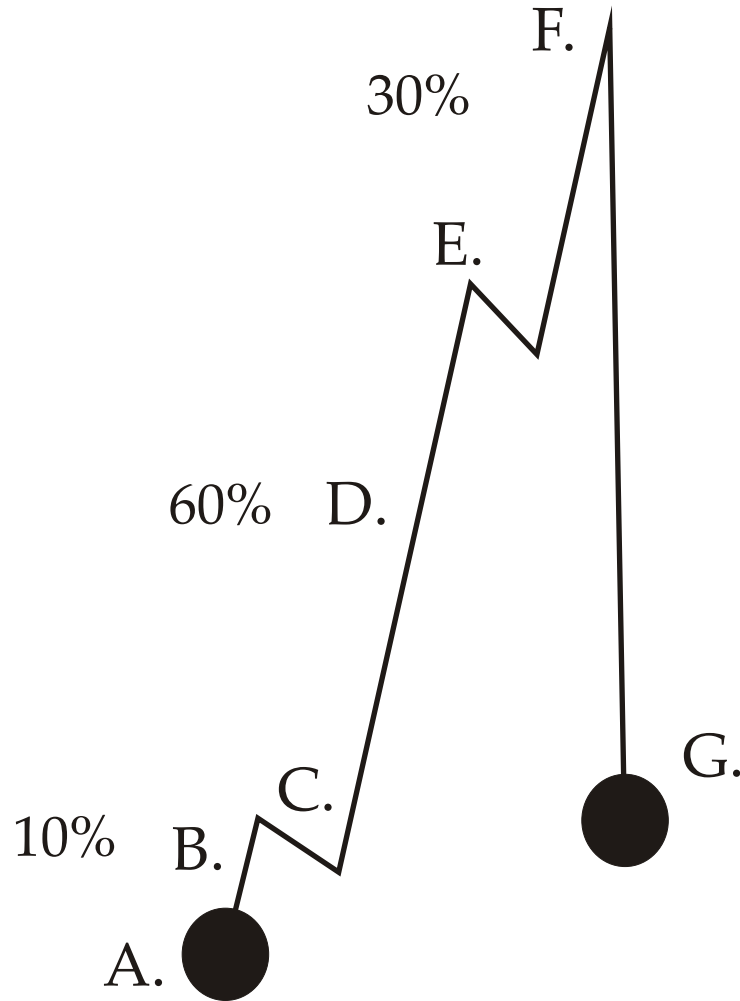
We call this The Divine Pattern.

three variables.

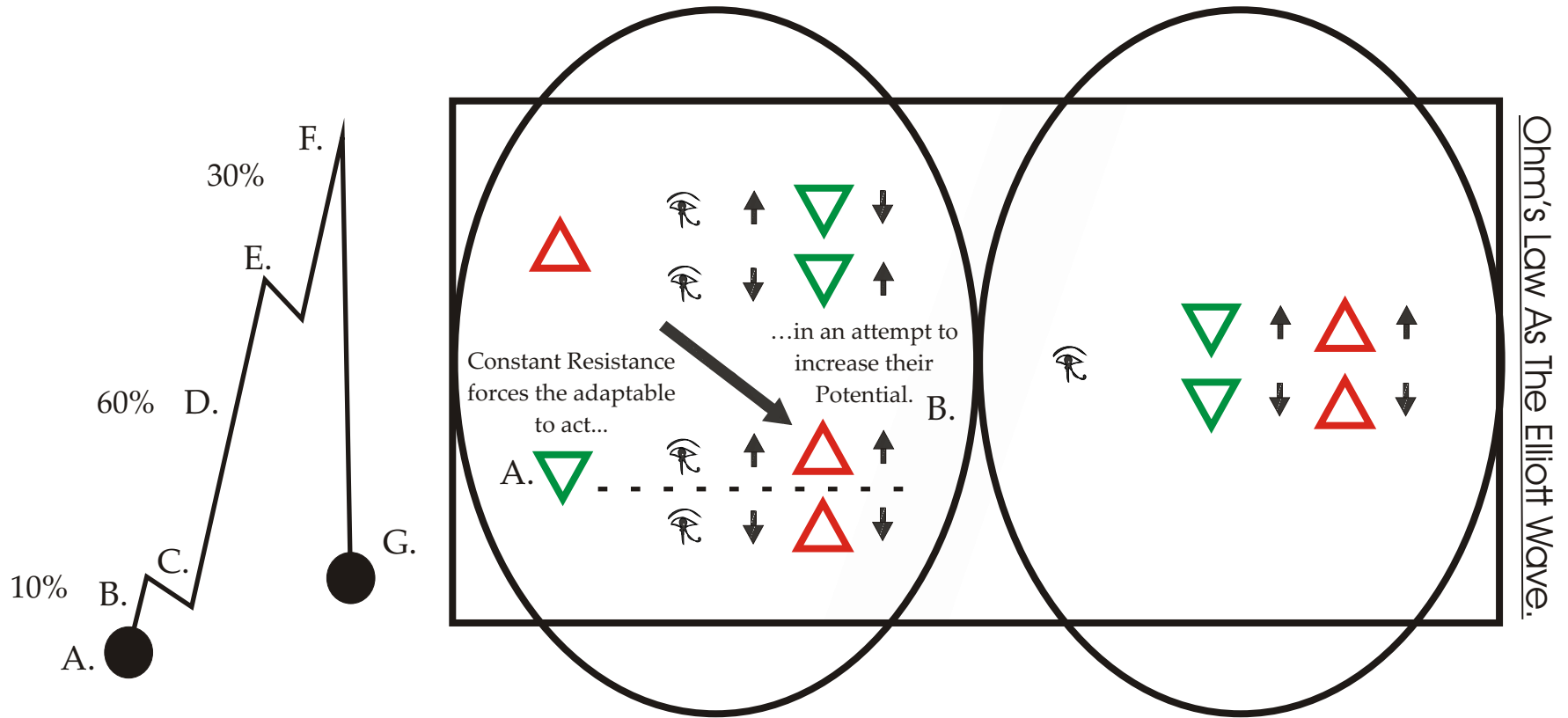
-  Resistance

In the Elliott Wave Principle "A" represents the constant Resistance Phase.
It is the Phase driven by DESPERATION.

"B" represents the charge of energy that gets released when
the adaptable are forced to increase the Intensity Of Their Focused Energy because
their circumstance is crushing them.

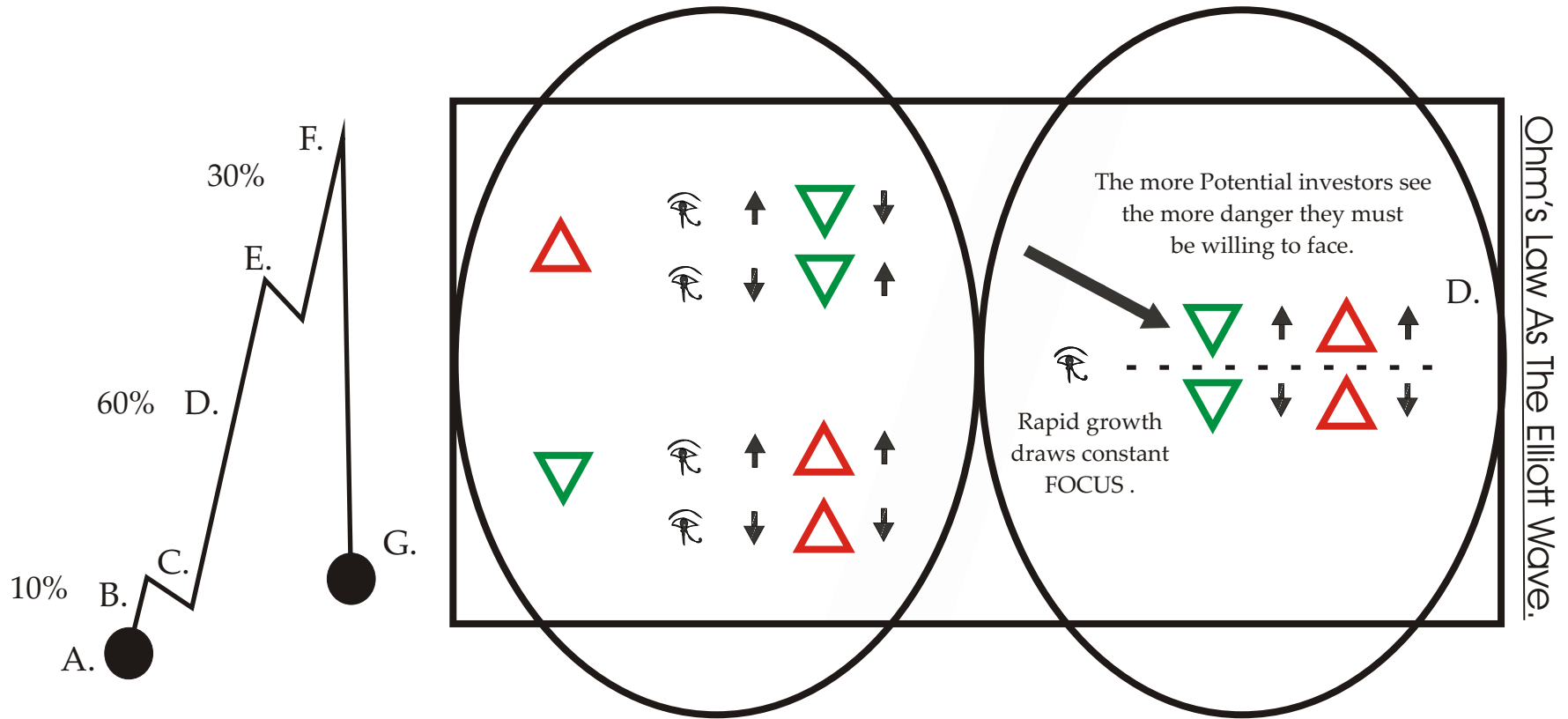


In this is the aspect of the Resistance Phase,
Ohm's Law proves...

If Resistance  is constant and Potential Difference,  also known as Motive Force, increases
Current, also known as Intensity Of Focused Energy , must also increase.

“C” represents the shifting of gears to The Current, or Intensity Of Focused Energy, Phase.
 All the activity created by the first 10% draws FOCUS and inspires others to dive into the market.

The next 60% of people do not have the vision to create something new on their own.
 However, they do see the Potential to benefit from the growth that is unfolding.
 In the Elliott Wave Principle “D” is the Phase driven by GREED.



In this aspect of the Current Phase, Ohm's Law proves...



If Current, also know as Intensity Of Focused Energy is constant and Potential Difference increases, Resistance, must also increase.

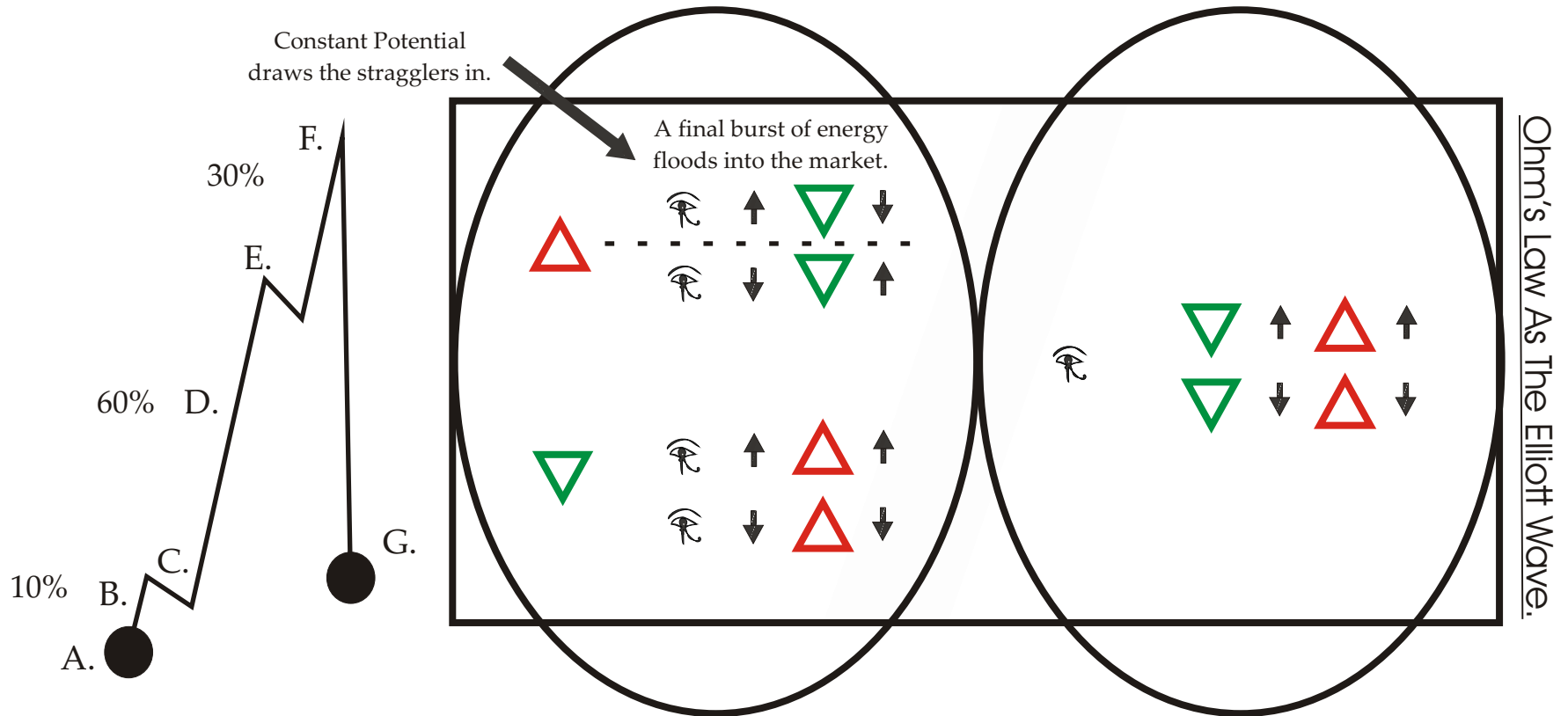


When being applied to The Elliott Wave Principle, the Resistance that is being referred to is RISK.
 The more physical assets you need as collateral to buy in, the more you stand to lose should the wave collapse.

“E” represents the shifting of gears to The Established Potential Phase.

As soon as the energy created by the frenzy of activity generated by the first 70% of participants starts to become exhausted the most basic human nature, “FEAR OF LOSS”, gets unleashed.

The push to “F” represents the final energy that gets drawn from the all people who FEAR they have missed out on the opportunity created by the first two bursts of energy. This last 30% Panic Purchase. They are the ones most likely to be stuck holding the over valued asset.



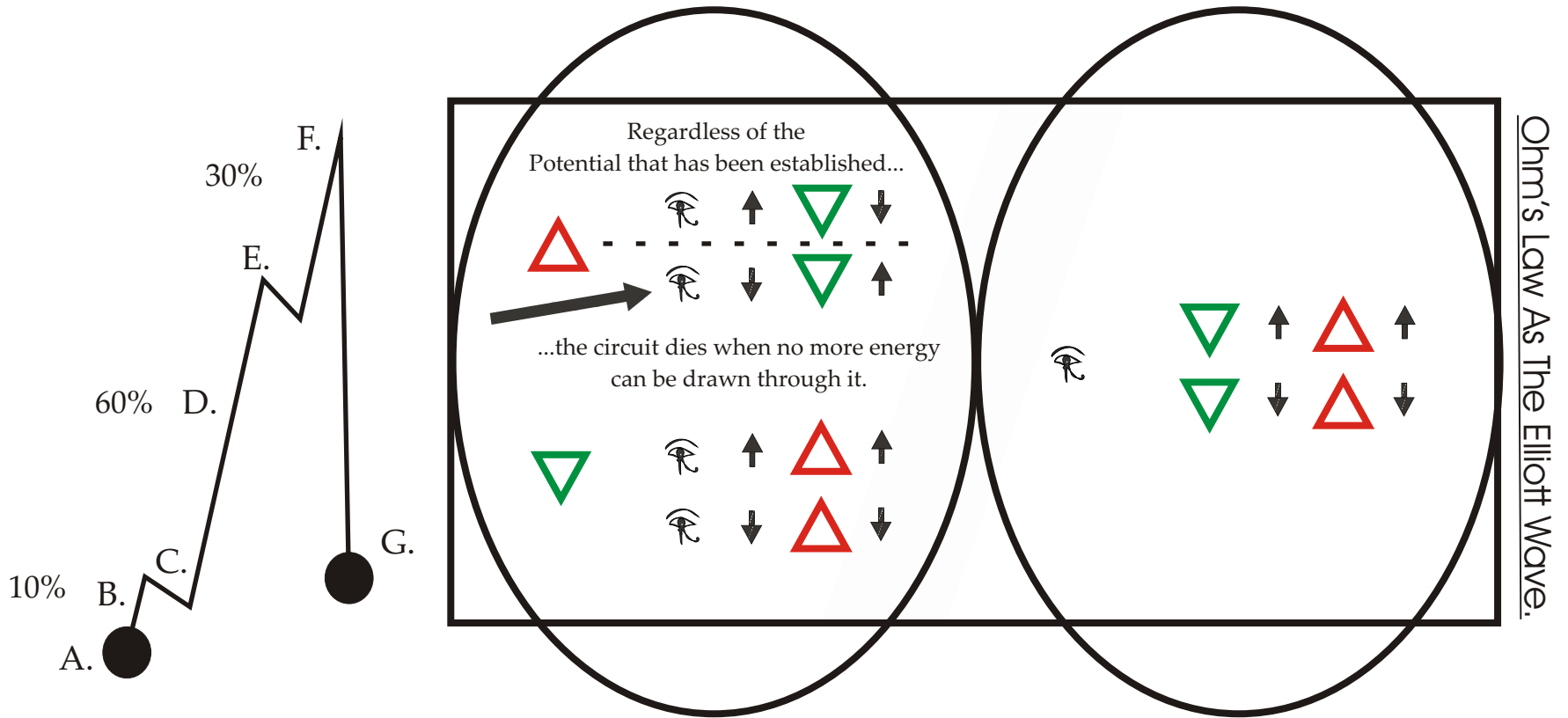
In this aspect of the Potential Phase Ohm's Law proves..

If Potential \triangle is Constant and, Resistance ∇ decreases, Current ⦿ must increase.

In the Elliott Wave Principle this decrease of Resistance is the total disregard for the RISK that prevented the person from investing in the first place. Once all logic has been removed from the equation emotional spending fuels the final burst of energy.

“G” represents the crash of The Elliott Wave.
 With no more people willing to invest, or to draw energy from, the wave collapses.

In this aspect of the Potential Phase Ohm’s Law proves that...
 If Potential  is constant and, Resistance  increases, Current  must decrease.



In the Elliott Wave Principle this increase of Resistance is the total unwillingness to RISK more. With no more people to draw in, the Intensity Of Focused Energy can no longer be maintained. People start to RESIST by questioning the legitimacy of the opportunity. Once this occurs all of the people who lost on the deal find them self in a new negative circumstance. This is the point when the cycle repeats.

position within the cycle.*

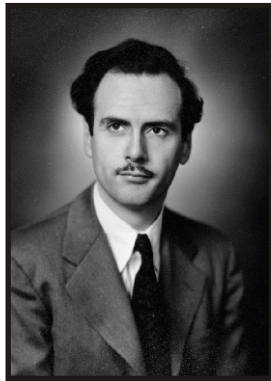
*The immediate circumstantial wave can easily be overpowered

Every tool or article we use becomes an extension of our self. Depending on how much more efficiently it allows us to perform a task determines which “old” tool will be abandoned.

Should one day the tractor and plow cease to be available we all starve because not only does no one know how to use the Ox plow, no more of them exist.

Each of these extensions are a conductive medium connecting you to another “thing”. When you have access to them the “content” within your self changes.

This occurs because the ENERGY or MOTION that can be released is inspired to be discharged by virtue of having the opportunity to do so.

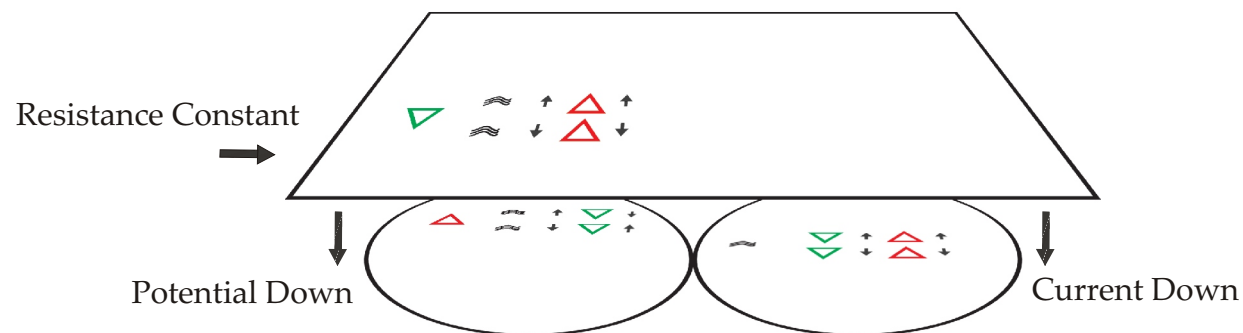
The characteristics of the medium, not the content delivered through it, affect the society in which it plays a role.

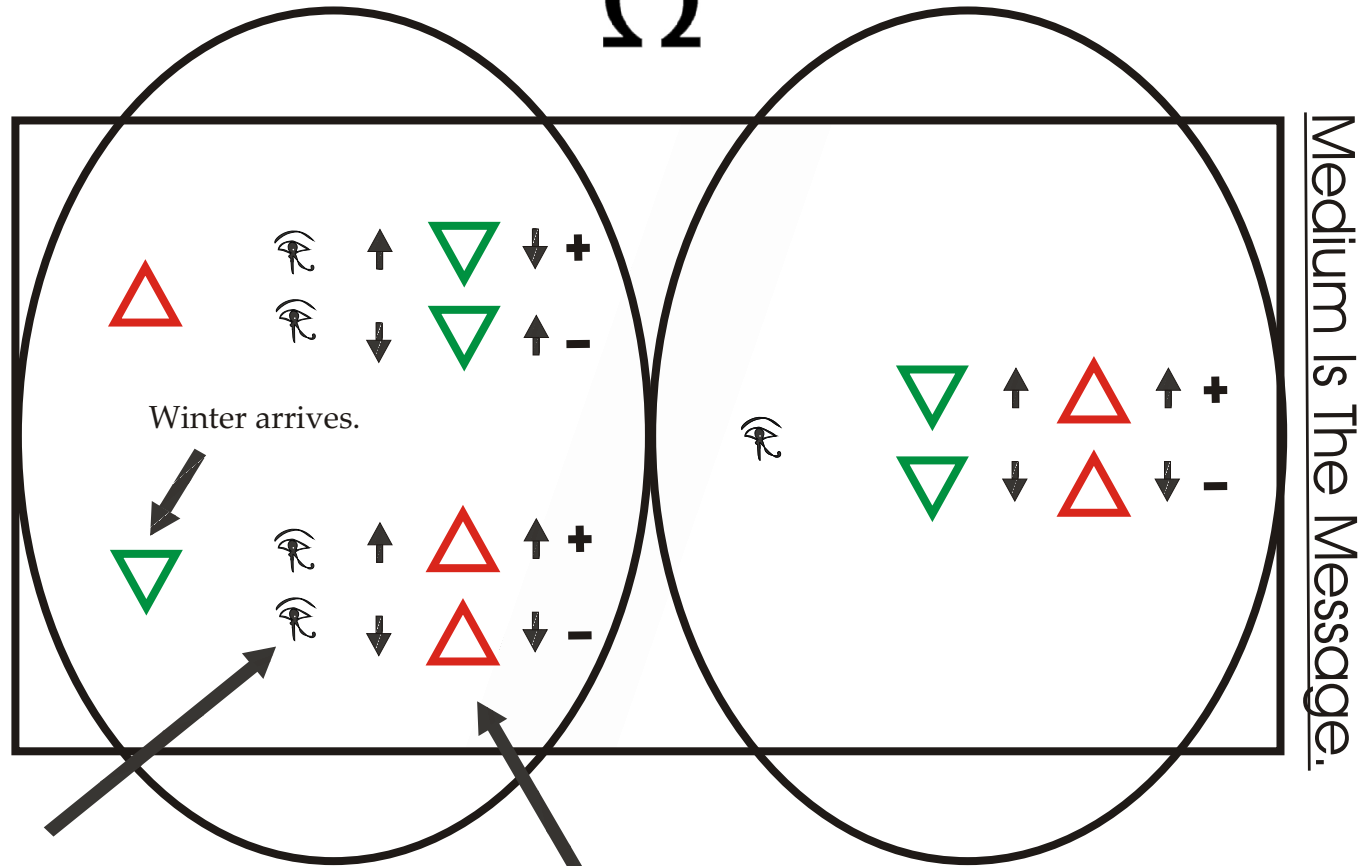
Let us observe the relevance of

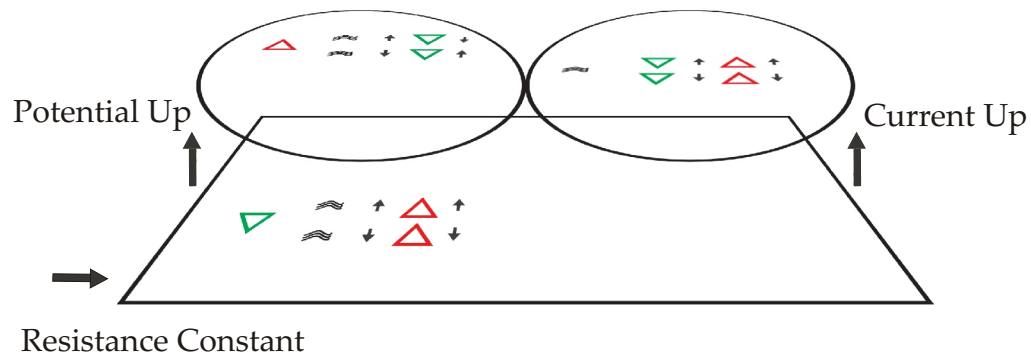
You EMIT, or do less outside, because the cold prevents you from being active outdoors.

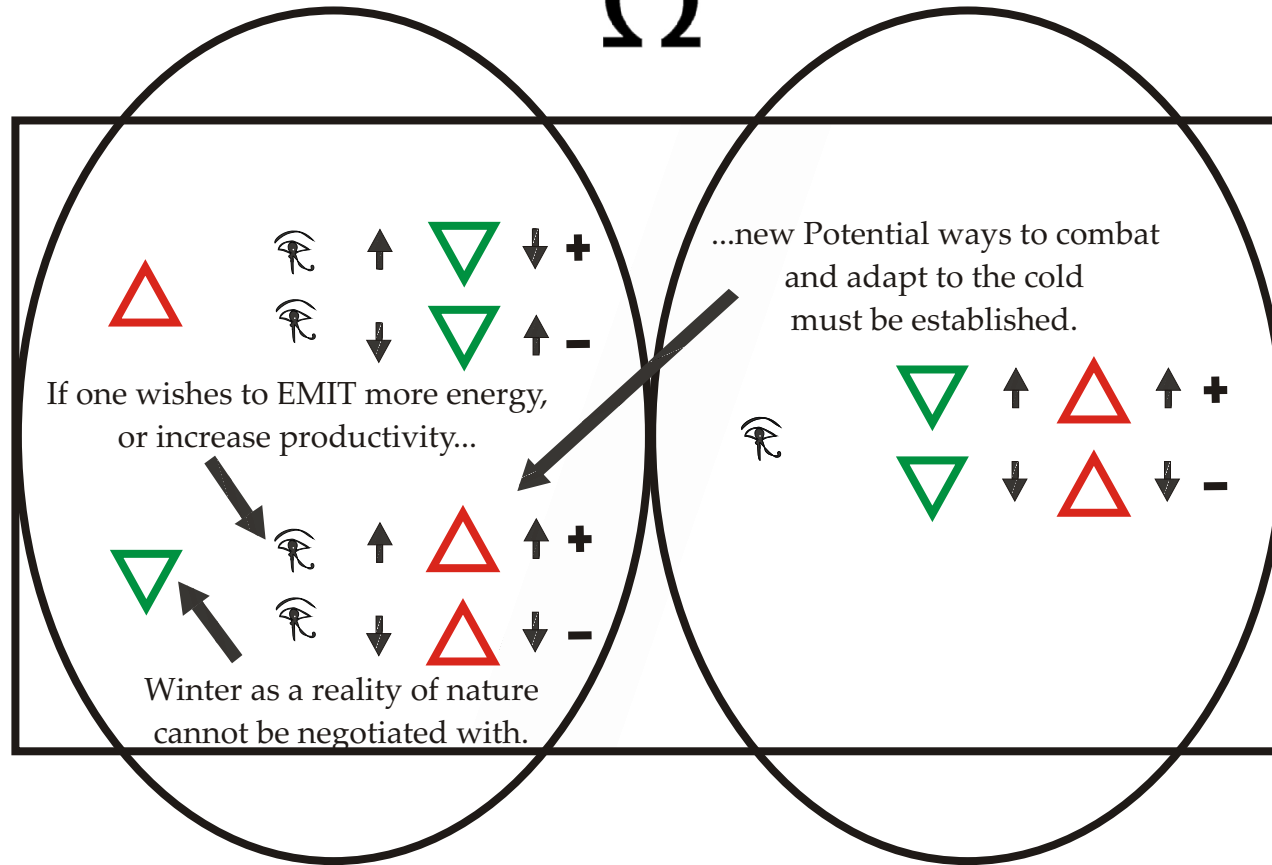
Once you think to cover your hands

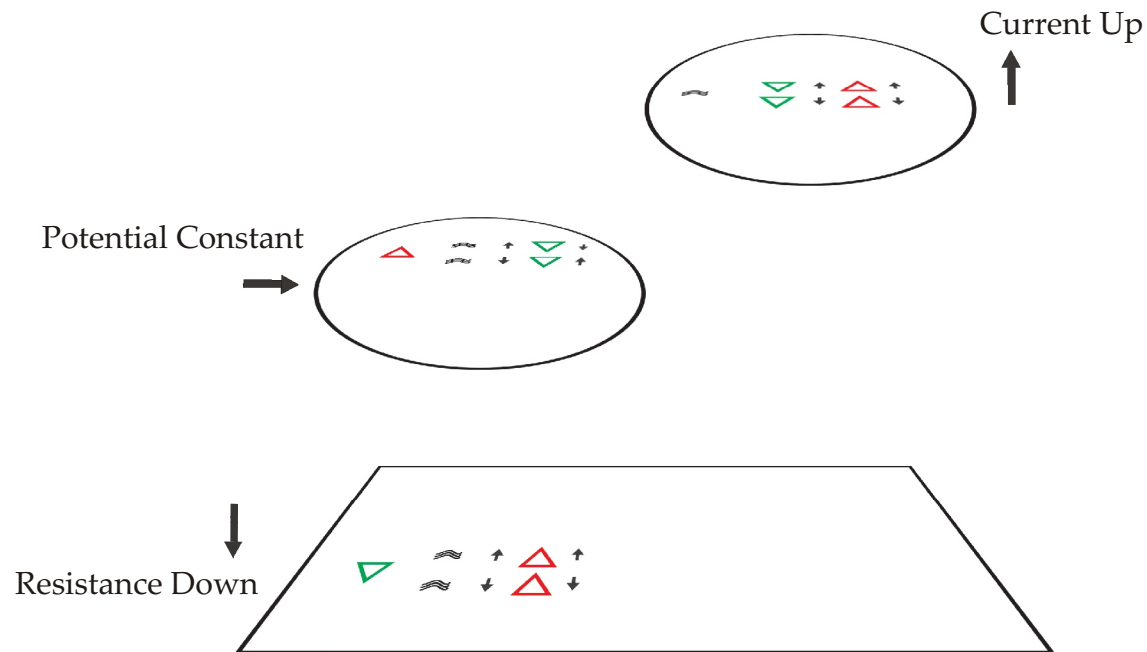
Once you manifest all of your different ideas to combat the cold,

they can be used all year round to move and manage all sorts of things too coarse for bare skin.

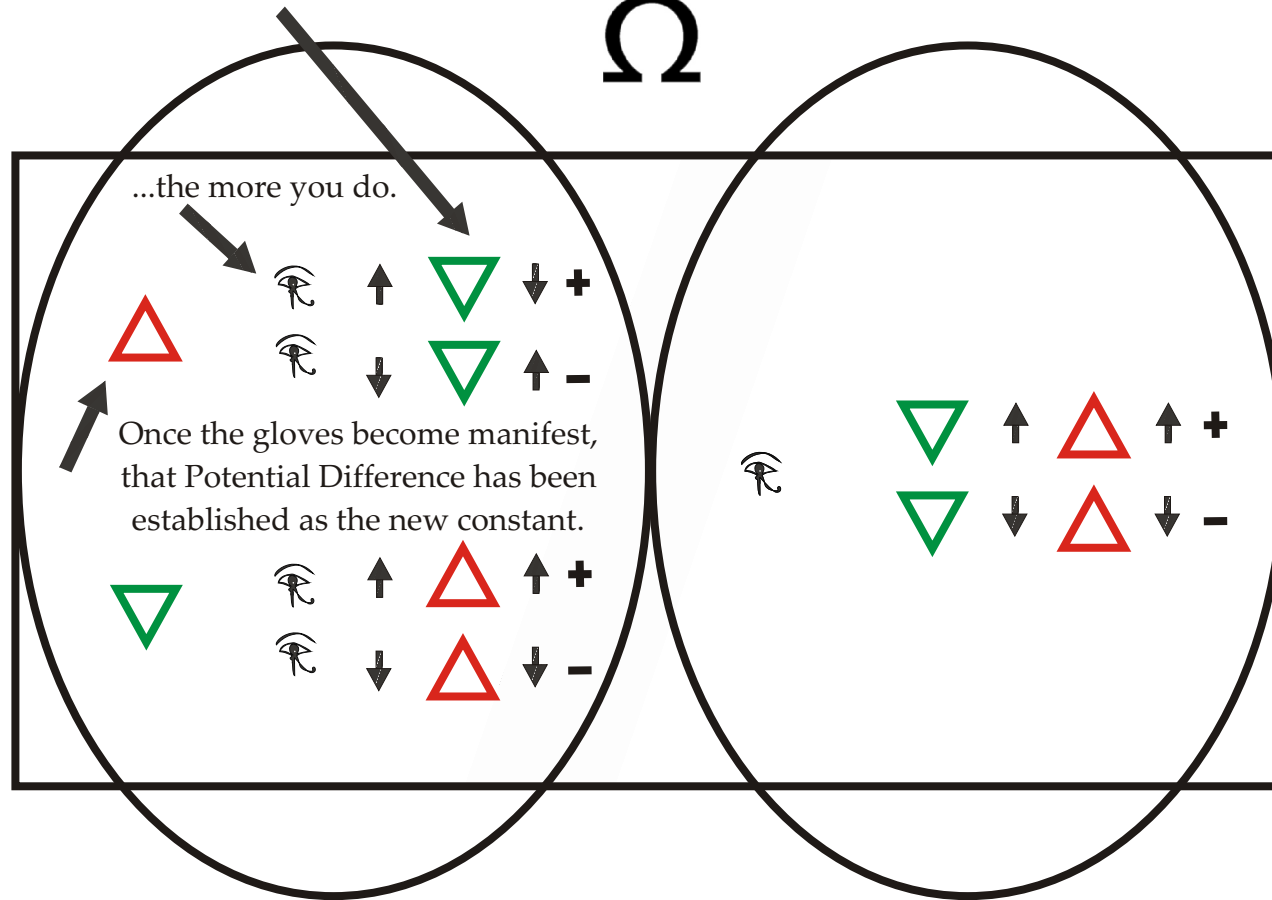
As you become identified with the new activities the gloves allow you to participate in

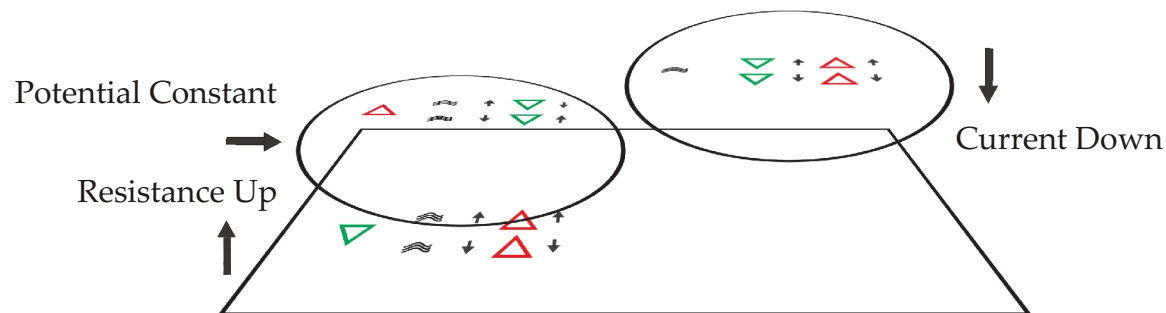


The Divine Pattern Unfolding.

you become dependant upon the gloves when ever it gets cold.

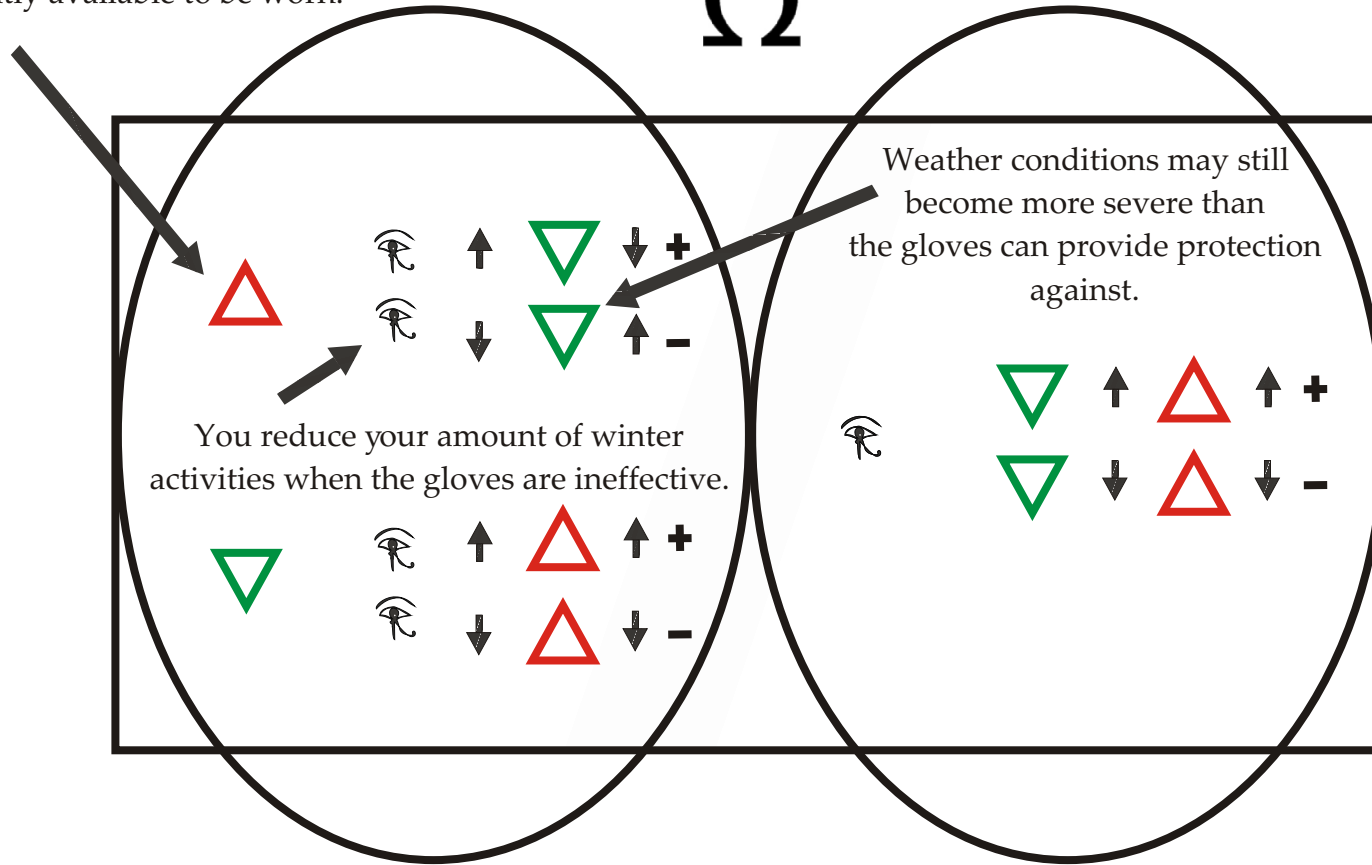
If the level of cold increase to the point that the gloves

In our example the gloves are “The Medium”.

“The Medium Is The Message”

because the nature of the medium, as an extension of the person, determines how the user modifies their behavior as a result of the medium existing.

Let us next apply this observation to a vastly more complex example.

Every individual, when not pursuing a mate or actively performing the tasks required to maintain their existence, seeks out one of two things, information or entertainment.

Those who seek information have the Potential for self improvement.

Those who seek entertainment, or distraction, prolong their mental development.

One cannot spend all day learning just like one should not spend all day living solely for distraction.

The distraction that is entertainment offers an often much needed way to decompress.

Nether are “good” or “bad” but there are consequences to both.

Smart Phone Technology has provided everyone with a screen that has access to all the information and entertainment ever created.

The screen itself can never force anyone to do anything.

What it does do is set tones.

Those a specific tone resonates with then ABSORB, or consume, more of that tone.

The desire to ABSORB more becomes the first modification of their behavior.

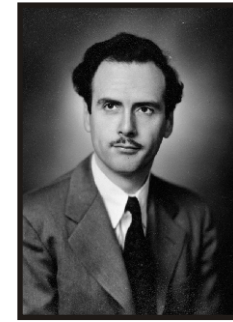
They, EMIT, or actively “seek out” other content offered that embodies their tone.

McLuhan's Observation Of The Tribal Drum.

In primitive cultures a drum was used as the first method of broadcasting. If the drum beat a certain way, it let those out hunting or gathering know key events. The village is under attack. A baby has been born. In McLuhan's time the tribal drum had evolved into the newspaper, radio, television and cinema. Messages sent through these mediums effectively tell all the rate and direction with which the majority are all meant to continue rowing.

In the late 1950s early 1960s McLuhan predicted that within two decades the individual would have at their disposal a device in which they could place a cartridge that would allow them to watch whatever content they desire whenever they desire to watch it. The first generation of these devices were the "Walkman" and "VCR".

Once these devices were made available to the general public, the tribal drum would lose its influence and society would begin to self program.

He predicted that, as soon as this event occurs major social change is inevitable.

Established institutions would either be forced to adapt quickly or find themselves extinct.

All media and educational infrastructure are delivery mediums for information.

To that point the tribal drum kept the masses so concentrated in a very specific, generalized, direction that, once this fragmenting of focus begins, the overhead infrastructure demands will become increasingly difficult to maintain.

Individuals no longer moving on mass as a single herd will be self-educated to the point established institutions, unable to keep up, will have little to offer them.

People will FOCUS on alternative opportunities in niche areas. New fields will be established that are so specialized that systems will not be able to afford catering to them. This will in turn further reduce the POTENTIAL of the old generalized infrastructure.

As independent alternatives arrive individuals will be less likely to financially support, or be willing to become indebted, for the “privilege” of participating in the experience these institutions have to offer.

This RESISTANCE will create a chain reaction throughout the entire system.

You don't need to lose fifty percent of your users to lose your business. You only need to lose the small percent that are the actual profit after all other expenses are paid.

Once the technology he predicted evolves, change will start coming faster and faster. This will have two major and many minor effects.

The first thing to happen, as the technology evolves, will be the inevitable splitting of FOCUS. Mental Concentration rates on average will rapidly decline. With FOCUS spread out over such a vast landscape an exponential decline of deep thinkers will occur.

The second thing to occur will be a return to a type of basic tribalism. The technology will allow like minded individuals to find each other and organize into smaller groups. A different tribe will be formed for every conceivable tone a person can possibly be identified with.

These groups will next begin to push their energy in every conceivable, previously unseen, direction. When you look at everything happening in the world today, does any of this sound familiar?

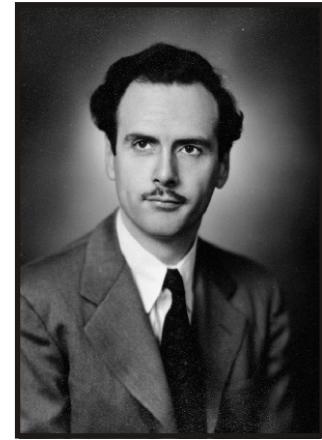

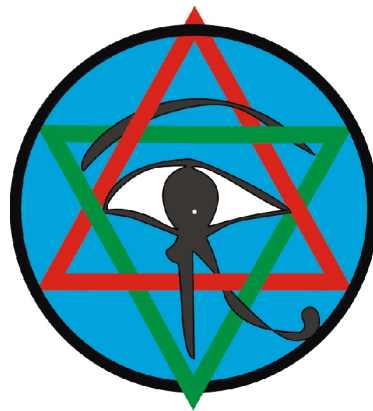
